WINTER SAFETY TIPS - 6 ITEMS YOU MUST HAVE IN YOUR VEHICLES FOR THE WINTER:

- 1. Blankets. Can be used for any type of emergency.
- **2.** Cell phone charger. Make sure your primary source of communication is charged for any emergency.
- **3.** Charged jump pack and or jumper cables. A jump pack can also power your cell phone and is a light source in an emergency.
- **4.** Water and non-perishable food. Extended emergencies in a vehicle are rare. However, help can sometimes be a long way off.
- **5.** Windshield wiper fluid/de-icer. Visibility is very important to your safety while traveling. A gallon of this fluid can also be poured under tires to melt snow or ice for traction.

Committee Updates

Trails and Recreation Committee

We wish to thank the many individuals who completed the recent survey soliciting views on possible new recreation amenities for the Glenwild community. The results have been reviewed and discussed by our Committee and by the full HOA board.

Three areas rose to the top of the survey results (shown in brackets are the % of responders who indicated that they were either "very likely" or "likely" to use the indicated recreation option, if it were to be installed): Pickleball (63%), Paddle Tennis (40%) and a Dog Park (60%). However, regarding the feedback with regard to the "frequency of use question" which followed, was slightly less enthusiastic. Additionally, there are some comments where owners questioned the need for any such amenities at all.

Given the less-than-conclusive results, and the fact that the Club has just recently made PickleBall play available on the tennis courts, it was the Committee's recommendation that each of these three topics be "tabled" for several months, to allow for more input from Glenwild owners. Architectural Review Committee

We have received multiple inquiries over what is happening with the house being built on Lot 99. This is the partially completed home on the right of Glenwild Drive as you come in the upper gate and drive down towards the Club. This is a spec home, we have been working with the builder and developer to get it completed. We have had ongoing discussions with all of the involved parties and we are not getting any cooperation at this time. We have issued multiple deadlines only to see them come and go. Currently we have handed this over to our HOA attorney and have put the responsible parties on notice. We hope to have a reasonable resolution to this matter but we are prepared to take all steps necessary to force completion.
